Thank you for coming to our first episode of the Louisiana De Jure Government where we hope to actually take this to a national level to secure our counties.

[Prepared statement by Kimberly England]

Not today, not tomorrow, not ever will we allow our liberties to be taken. Today we unite in the forefront for God and our country and for the people of the United States of America. Of the People by the People for the People. From every walk of life from every organization we promise to come together once and for all - today. It is time to implement our country's de jure grand juries, republic de jure grand juries and the republic de jure government. We the people and a body politic and/or assemblies for governing. Please join us as we take the final steps in securing our liberties by building our house from the foundation up . . . one county at a time one republic at a time for our beautiful country.

Phase one is preliminary it can be changed at any time. It's a draft. It can be deleted, added to, whatever. At this point in time it is still a work in progress.

[Phase one plan]

- 1) We want to keep our Declarations and Articles of Confederation in tact and re-implement that Declaration
- 2) We want to write a Constitution for the counties and the Republic, wipe the slate clean on the Republics and write a new Constitution for every Republic across the country - in unity.

- 3) They can be changed later added to amended whatever.
- 4) Build and utilize a body of We the People in the counties first The first person signed on becomes the chairperson for the Republic and will assist a chairperson for each county to set up their pool of the body of people and then a jury. The body of the people are the governing of every county of every republic that is why it is quoted as We the People

There will be 27 in each country including the chairperson and when the body of people and the jury is set for each county a body politic will be set in place for boards of directors and governing.

The republic chairperson will disseminate the entire plan to the county juries to prepare their documents, which will be presented in unity across the country in all 3140 counties. The body will elect the sheriff, the electorate and so on for elections of the new government. I would like to have that completed by October 2010 elections. Then the republic body will follow suit to certify and authenticate the election document. At the same time the county de jure grand juries will be fulfilling their orders to their newly elected officials which are the following:

- 1 - Going back to the gold and silver currency only
  - 2 - Getting our gold back from Fort Knox
  - 3 - They will elect a sheriff and a marshal for their republics and counties
  - 4 - We will mandate the sheriff seal the borders
  - 5 - We will mandate the sheriffs remove all foreign corporate tax collectors of the de facto and foreign crown court
  - 6 - We will mandate sheriffs to serve all courts and businesses to nullify ALL contracts
  - 7 - We will mandate sheriffs to serve a cease and desist orders to the appropriate places of all collections, the foreign IRS, state taxes, property taxes, income taxes and removal of liens on properties, businesses, vehicles, and bank accounts
  - 8 - We will mandate sheriffs to place a moratorium on foreclosures in the counties until the plan can implement the nullification of all contracts. Once the contracts are nullified the juries will take legal action on the people's behalf
  - 9 - Have every federal agency removed from every county
  - 10 - Review, re-establish, and or remove state agencies if necessary
  - 11 - Reassess and implement metes and bounds
  - 12 - Every person will have rights to alodial title
  - 13 - There will be no more eminent domain
  - 14 - No more wage taxes
  - 15 - Put common law back into the courts
  - 16 - No plates on vehicles or inspection stickers period. BMV will be gone
  - 18 - Every person will have a sovereign id. We will make them
  - 19 - Reintroduce into our schools into the true history of our country. The pledge of allegiance, and in god we trust will be back in. If the schools don't adhere we will fire the staff and start over
- Next - Every person should file an unincorporated pure business trust for themselves taking their trusts away from the de facto and utilizing umbrella trusts if necessary.

Let me give you an example Acorn, SEIU and all that stuff that went on with the investigations and everything and there were over 800 companies . . . same thing with the courts, judges and so forth. They have what are called unincorporated pure business trusts that can't be touched. So if we do the very same thing for our personal selves, they won't be able to touch our trust anymore either. And we'll go a little further in detail with that in a minute.

There will be no need for police departments. The sheriff is the ole man in town and so on.

And it is still being revised.

But the body of the people in each country of the republic will work together in unity to make the common goal across the country happen. Documents will be provided to prepare and get ready for all the counties and republics to serve their documents at the same time utilizing their Sheriffs and all 3140 counties and republics will work in unity together.
